

Article 72

I. - The code of postal and electronic communications is amended as follows:

1 After 12 ° of II of Article L. 32-1, is inserted a 12 ° as follows:

"12 At a high level of environmental protection and health of the population, together with the ministers responsible for health and the environment;"

2 After the second paragraph of Article L. 34-9 is inserted the following paragraph:

"The radio terminals to be connected to a public network for the provision of telephone service can not be marketed without an accessory to limit the exposure of the head to radio emissions in communications. "

3 Article L. 34-9-1 is completed by two paragraphs as follows:

"The measurement result is sent by the bodies mentioned in the second paragraph in the National Frequency Agency, which ensures the provision of the public, and the French Agency for Environmental Health and Labour.

"When the measurement is carried out in residential premises, the results are sent to owners and occupiers. The occupants of the premises may object to the making available to the public of these results. These results should indicate the name of the supervising office. "

I a (new). - After the third paragraph of Article 3-1 of Law No. 86-1067 of 30 September 1986 on freedom of communication, it is inserted the following paragraph:

"The Higher Audiovisual Council shall ensure that the development of audiovisual media sector is accompanied by a high level of environmental protection and health of the population. "

II. - Chapter I of Title III of Book II of Part V of the Public Health Code is supplemented by two articles L. 5231-3 and L. 5231-4 read as follows:

Art. L. 5231-3. - Any communication, regardless of income or support, aimed directly or indirectly promote the sale, provision, use or the use of mobile phones by children under fourteen years is prohibited.

Art. L. 5231-4. - The distribution payment or free items containing radio equipment whose use is specifically dedicated to children under six years may be prohibited by order of the Minister for Health, to limit excessive exposure of children . "

III. - After section 17 of the Act of June 15, 1906 on the distributions of energy, it is inserted Article 17a reads:

Art. 17a. - People involved in the transport of electrical energy must make regular checks of electromagnetic fields induced by power lines. The result of these measures must be submitted annually to the French Agency for Health Safety Environment and Labour will make public. "

IV (new). - In Chapter III of Title V of Book IV of Part IV of the Labour Code, it is inserted item L. 4453-1 as follows:

Art L. 4453-1. - The rules for the prevention of risks to health and safety of workers exposed to electromagnetic fields are determined by decree of the Council of State made under Article L. 4111-6 of this Code.

"This decree is consistent with the principles of prevention set out in Articles L. 4121-1 and L. 4121-2 of this Code. "

V (new). - The single chapter of Title I of Book V of Part II of the Education Code is supplemented by Article L. 511-5 as follows:

Art. L. 511-5. - In kindergartens, elementary schools and colleges, a student's use of mobile phones is prohibited. "

VI (new). - Local authorities who conduct experiments on average exposure rate transmit results to the National Agency of Frequencies and the French Agency for Environmental Health.

VII. - 2 ° of I enters into force at the expiration of a period of six months following the publication of this Act.
